Children, Young People and Families Implementation Plan 2022-2025



Context

The Implementation Plan has been developed to ensure the effective delivery of Council's Children, Young People and Families Plan 2021-2025.

The Implementation Plan details the actions that will be undertaken to achieve the Children, Young People and Families Plan's vision of a community where children, young people and families are healthy, resilient, empowered, safe and belong.

The actions correspond to the three outcome areas in the Children, Young People and Families Plan:

- 1. Inclusive City and Communities
- 2. Improved Health and Wellbeing
- 3. Lifelong Learning and Participation.

Developing the actions

The actions have been developed through feedback from children, young people, families and community partners on what Council can do to improve health, wellbeing, educational and employment outcomes. Local evidence and data was also used to identify areas for focus.

Actions in practice

Completing the actions will require collaboration with community partners, children, young people and families. This will include children, young

people and family's opinions being sought on matters that impact them, partnerships with community organisations and state government.

While most of the actions are resourced, state government funding and other grants may be needed to ensure all the actions can be completed.

Monitoring and reporting

The Implementation Plan will be reported on each year to measure progress on the actions. The annual report will highlight achievements and identify where additional efforts are required.

Outcome 1: Inclusive City and Community

There will be respect, acknowledgement and celebration of diverse cultures and identities, recognising the benefits diversity brings to the community. Places and spaces will be accessible and meet the needs of children, young people and families.

There will be opportunities for young people to engage in further training and pathways to employment. Children and young people will be involved in decisions that impact them. They will be consulted in age-appropriate ways and their opinions will be valued.
