# Visitor and Temporary parking permit application

## Eligibility Criteria

### Visitor including Weekly Parking Permits

- Visitor parking permits will not be issued to properties subdivided after **31 August 2011**.
- A visitor permit is only valid while the resident resides at the address shown on the approved application form and will only be issued to properties that have parking restrictions in their street.
- Visitor parking permits can only be issued for use in an applicable vehicle. The permit is not permitted to be used on a boat, bus, trailer, truck, caravan, motorcycle or vehicles greater than 4.5 tonnes or 12 metres in length.
- Visitor parking permits do NOT guarantee parking will be available.

### Service Parking Permits

- Live in a property in Merri-bek
- Produce evidence of your residency in Merri-bek (rates/tenancy agreement, drivers licence both sides, utility bill)
- Produce evidence of tradespeople, removalists etc servicing your residency (e.g. quote or receipt of services) that specify the dates when the work will take place
- The service provider can apply for this parking permit on your behalf, their application must include a letter or email from the resident providing consent.

### Merri-bek User Permit

- Anyone is eligible if parking in a street with timed restrictions
- This does not include areas with restrictions of 30 minutes or shorter or where signage is in place stating permits are not valid (e.g. in front of commercial properties).

## Permit Conditions

- The parking permit **Must be clearly displayed** on the inside, lower left-hand corner of the front windscreen.
- A parking permit not displayed as described above is invalid and any infringement notices issued for not displaying a valid permit will not be withdrawn.
- A statutory declaration is required for replacement permits. An administration fee is charged for replacement permits. We do not issue replacements for Visitor parking permit books.
- A free replacement permit will be issued if the applicant's car is stolen and a copy of the police report is produced.
- Permits are not valid in areas with restrictions of 30 minutes or less.
- Permits are not valid in No Stopping, No Parking, Clearway, bus, taxi or Loading Zones or any other red signed area.
- An expired permit is not considered a valid permit and any infringement notices issued for not displaying a valid permit will not be withdrawn.
- Photocopied or misuse of permits will result in the permit being cancelled. No replacement or refund will be provided.

- In addition to the above conditions, the visitor permit must be clearly displayed on the inside, lower left-hand corner of the front windscreen with the day, date and month erased.
