Election of Deputy Mayor

The Acting Chief Executive Officer, in accordance with section 25 of the *Local Government Act 2020* and the Governance Rules, invited nominations for the office of the Deputy Mayor for the term ending 18 November 2026.

Cr Abboud nominated Cr Irvin, seconded by Cr Svensson.

Cr Irvin accepted the nomination

Cr Yildiz nominated Cr Theodosis, seconded by Cr Politis .

Cr Theodosis accepted the nomination.

As there were two nominations for the office of Deputy Mayor, the Acting Chief Executive Officer put it to the vote.

The vote resulted in five (5) votes for Cr Irvin and five (5) votes for Cr Theodosis.

As no candidate received an absolute majority of votes, the Acting Chief Executive Officer advised that a second vote will be conducted.
