4. Term of Mayor

To fulfil the statutory obligations of section 26(3) of the *Local Government Act 2020* (the Act), before the election of the Mayor, a Council must determine by resolution whether the Mayor is to be elected for a 1 year or a 2 year term.

Historically, Moreland has elected a Mayor for a 1 year term only. The recommendation is that Council continues this precedent and sets a 1 year term for the 2021/22 Mayoral year. However, it is open to the Council to determine a two year term instead.

In accordance with Council's Governance Rules, the Mayoral term determined by Council will also apply to a Deputy Mayor

In accordance with section 26(4) the Act, the next election of the Mayor and any Deputy Mayor will be held as close as possible to the end of the 1 year term as possible.

Recommendation

5. Election of Mayor

The Chief Executive Officer, Cathy Henderson, in accordance with section 25 of the Local Government Act 2020 and Moreland's Governance Rules, invited nominations for the office of the Mayor for the 2021-2022 Mayoral year.

Cr Panopoulos nominated Cr Riley. Cr Riley accepted the nomination.

Cr El-Halabi nominated Cr Tapinos. Cr Tapinos did not accept the nomination.

Cr El-Halabi nominated Cr Pavlidis. Cr Pavlidis did not accept the nomination.

As there was only one nomination for the office of Mayor, the Chief Executive Officer declared Cr Riley elected as Mayor of Moreland City Council for the 2021-2022 Mayoral Year.

The newly elected Mayor, Cr Riley received the Mayoral Chains and assumed the Chair.

7. Ceremonial Mayoral Speech

In accordance with sub-rule 3.5.4 of the Governance Rules, upon being elected, the Mayor may make a ceremonial speech, outlining the priorities of the year ahead based on the previously adopted Council Plan.

Mayor, Cr Mark Riley

I would like to begin by acknowledging that this meeting is being held on the lands of the Wurundjeri woi wurrung people. The land was taken from them without a treaty process, consent, or compensation, and sovereignty was never ceded. I wish to acknowledge the WW as the Traditional Custodians of these lands and waterways and would also like to pay my respect to their Elders past, present, and emerging, as well as to all First Nations communities, who significantly contribute to the life of this area. I acknowledge their cultural heritage, relationship with Country and the contribution they make to the life of our city.

I would also like to acknowledge any members of parliament, former mayors and councillors, and other community leaders who may be watching tonight.

Cr Jo Connellan, former Mayor Natalie Abboud and former Cr Jess Dorney.

To my fellow Councillors, including past Mayors Davidson, Yildiz, Tapinos and Carli Hannan and Crs Pavlidis, El Halabi, Bolton, Conlan, Pulford and Panopoulos, residents of Moreland and friends.

I am incredibly proud to stand here as the elected Mayor of this wonderfully progressive, vibrant, diverse and connected city. And prouder still to stand here as the first Out Queer Mayor for Moreland. It is a great honour and responsibility. I thank my fellow Councillors for your support and entrusting me to lead this Council for the next 12 months. I will serve the people of Moreland with passion, pride and integrity.

I want to at this time acknowledge that we as a community have been deeply challenged by the coronavirus pandemic. I acknowledge the extraordinary community

efforts to maintain public health and continue our local economy. I also acknowledge community suffering and grief as a result of the pandemic, and we are reminded this week of the very sad illness and deaths which occurred last year at St Basils Home for the Aged in Fawkner.

In looking to the future, I am committed to leading Moreland City Council in achieving the aspirations of our community, as expressed in our Community Vision and Council Plan. As Councillors, we have just completed our first year together as Councillors, and all eleven Councillors share equally in the decision-making process.

Councillors, I commit to each of you, that I will work to foster collaboration as a team, so we can continue to deliver for our community in the coming year.

To all previous Moreland Mayors, I thank each of you for your individual contributions that have made Moreland a better place.

To the outgoing Mayor, Cr Annalivia Carli Hannan; I acknowledge the passion and care you brought to the role. You led our Council well in supporting the community throughout this second year of the pandemic. You were a leader in vaccination and health messaging, in our efforts to provide relief and support to our community at this time of need. And you led the Imagine Moreland engagement process as our community came together with Council to decide our vision for the future.

Thank you, and congratulations on your Mayoral year.

Thank you to each of the Councillors for your contributions over the past year.

I recall my first election as the SRC President at Warragul Tech School – not a patch on Local Government Mayoral elections though!

I want to acknowledge the important role models in my life and their influence on me as person and as a teacher/librarian/community worker and Councillor.

Firstly to my mother Billie – she is not only smart with the sharpest of minds, she is also hard working, committed, generous, and compassionate. Qualities I aspire to.

A shout out Chris Scott (Christine) a pioneer leader as Primary School Principal and the first woman to take on that role and to usher in sweeping changes at FNPS in the early to mid-1980s.

To former Greens Councillors, Fraser Brindley, Jo Connellan, Andrea Sharam, Lenka Thompson, Samantha Ratnam, along with my colleagues from the last Council Term – Natalie Abboud, Jess Dorney and Dale Martin.

Their contributions to this municipality as individuals and as members of the Greens and as Councillors in this chamber are significant. The progressive work they have undertaken and their collaboration with Councillors of all colours over 2 decades is immense. Thank you. This apprenticeship was invaluable to me with these wonderful mentors.

I'm honoured to be working today, closely too, with Angelica Panopoulos, Adam Pulford and James Conlan. They have taken on this role of Councillor with gusto and great care. It's been very challenging during these COVID times but I know they are each committed to working with all Councillors around this room. I look forward to strengthening the cooperation and collective endeavours for this City with all Councillors.

Worldwide, COVID-19 is one of the biggest challenges we have ever faced. The pandemic continues to affect everything we do as a community, but with vaccinations we can see the light at the end of the tunnel as a sense of normality slowly returns. As a Council, we will continue to provide front-line community support for those who need it, as well as supporting the important vaccination efforts across Moreland so that the services we are responsible for continue to be delivered, strengthening community participation and making Moreland distinctively inclusive.

So far, we have supported 17 COVID-19 vaccination pop-up clinics across Moreland. We are working with local groups, the Victorian Government and neighbourhood houses to provide culturally appropriate food relief. We are working extremely hard to reach all of our diverse community groups through programs such as the Moreland Connectors, so our residents feel educated and supported to become vaccinated and protected against the virus. Our community partners and bicultural workers are communicating health messaging to our community, protecting and saving lives.

We are supporting our local businesses as they recover from the economic impacts of the pandemic. We are also responsibly managing Council's financial position. We know our services are vital to the community's recovery, and despite the financial constraints, we are up for the challenge. Our community is resilient, and I know we will continue to work with everyone as we move into the recovery phase of the pandemic.

Yet while the pandemic continues, Moreland continues to face plenty of other challenges.

Climate change is upon us and is a growing challenge and Moreland Council will continue to lead on addressing the climate emergency. A warming planet is a risk for everything we hold dear at Moreland – our environment, our health and wellbeing, our vibrant local economy. This is a critical priority for us. While our national leaders may disappoint us day after day, year after year and especially in Glasgow at COP26 Moreland will continue to work with the community to meet this challenge in any way we can for the children born this past year and for those born in the days to come.

Our municipality is particularly susceptible to heat building up in our urban areas due to climate change. This is because of rapid urban densification, low levels of tree and vegetation cover and the sheer amount of solid surfaces in places such as shopping strips. We have various strategies to tackle these challenges. Our Zero Carbon Moreland 2040 Framework sets the vision and pathway for zero carbon emissions across our community by 2040. But we need to continue to work with the entire community to respond and adapt to climate change. This includes working with our state and federal governments putting in place policies for Australia to transition to a zero-carbon future.

So, how will we meet these challenges and what is in store for Moreland Council in the near future?

Councils set goals, make plans and define actions through the development of council plans. In the past 12 months, our Community Panel developed our Moreland Community Vision, we developed the 4-year Council Plan and the 10-year Financial Plan with close community consultation as part of the Imagine Moreland project.

The Moreland Community Vision informs our Council Plan and other strategic plans. It was developed by a panel of 44 community members, who were chosen at random to match the demographic characteristics of Moreland. We are incredibly proud of this deliberative engagement and it reflects a strong relationship and trust built with the community.

Our Council Plan has 5 themes:

- An environmentally proactive Moreland
- Moving and living safely in Moreland
- A healthy and caring Moreland
- Vibrant spaces and places in Moreland
- An empowered and collaborative Moreland

Some of the plans we have in place to achieve an environmentally proactive Moreland include:

- accelerating the shift to zero carbon emissions in energy, transport and waste
- protecting our trees and planting more of them
- increasing accessible and inclusive open spaces, for example through our A Park Close to Home program where we purchase land to create open space in areas of Moreland that need it most
- Striving for zero waste to landfill, including through kerbside waste reform.

To help our community to move and live safely in Moreland, we will:

- Build safe, accessible and high-quality bike and pedestrian infrastructure
- Advocate to improve public transport capacity and equitable access across Moreland
- Improve cycling and pedestrian transport options, prioritising the north of Moreland
- Review our Transport Strategy.

To achieve a healthy and caring Moreland, we will:

- Deliver the Glenroy Community Hub
- Upgrade the Fawkner Leisure Centre
- Develop and implement a Climate Resilience Strategy
- Implement plans for our younger residents, families and those with a disability, and
- Continue to invest in services for our older residents.
- To find employment pathways for our Indigenous peoples/First Nations.
- And we've enormous work to do to repair the hurt and atrocities that Indigenous Australians have endured by continuing our reconciliation work and setting the ground work to a Treaty.

Some of the things we will do to create vibrant spaces and places in Moreland include:

- Deliver the Saxon St Community Hub in Brunswick, a \$22.6 million redevelopment as part of the Brunswick Design District that will provide open space, room for our community and creatives and we will create more than 100 jobs in the creative industry
- Continue our mission to create affordable housing for the community including through building affordable housing on Council land
- Continue our Parks Close to Home Program which creates new parks in places where they are needed most
- Support the Brunswick Design District as a State-designated creative precinct

And to realise our final Council Plan theme, an empowered and collaborative Moreland, some of our activities will include:

- Implementing our Community Engagement Policy. This policy has new standards to improve the quality of the work we deliver and how we communicate with and involve the community in Council decision-making.
- Our Gender Equity Action Plan
- Our Child and Youth Engagement Framework to help children and young people engage in civic participation and community life
- Preparing a revised Open Space Strategy
- Our Accessible and Inclusive Communications Policy

I know we have an amazing community, but the past two years have proven what an incredible, resilient and caring community we have. It is a great honour to lead the Moreland community into the next phase of the pandemic and into the clear blue sky on the other side.

There's no doubt Moreland is a great place to live, work and play, but we know there is always work to be done.

I know this team of Councillors we have are up to the challenge and I look forward to working with each of them, Council staff and the community to make Moreland an even better city.

As there was only one nomination for the office of the Deputy Mayor, the Chief Executive Officer declared Cr Tapinos elected as Deputy Mayor of Moreland City Council for the 2021-2022 Mayoral year.

10. Adoption of Council Meeting Dates for 2022

Council's Governance Rules provide that Council fixes the date, time and place of all Council meetings for the following calendar year, including meetings designated for Planning and Related Matters.

Council by resolution, or the Chief Executive Officer, may change the date, time or place of, or cancel, any Ordinary meeting which has been fixed, or schedule an additional ordinary meeting and must provide notice of the change to the public.

The proposed Council Meeting Schedule (Schedule) for the period January to December 2022 has been drafted to enable Council to effectively carry out its decision-making functions for the year. The Schedule includes the times and dates for Council meetings and Council meetings designated for consideration of Planning and Related Matters.

Meetings are generally held on a Wednesday evening in the Council Chamber at the Moreland Civic Centre.

The election of the Mayor must be held on a day that is as close to the end of the one year term as is reasonably practicable. It is proposed that the next meeting to elect the Mayor be held Tuesday, 29 November 2022.
